Dear Ms. Davis:

I have been notified of the above defendant's parole hearing set on July 23, 2020 at the West Tennessee State Penitentiary. This office strongly opposes his early release on parole. Austin Drummond is a dangerous felony offender and confirmed member of the Vice Lords. On July 31, 2013, he entered a Circle K convenience store and pointed a revolver pistol at the victim in this case as he demanded money from her. He was convicted by a jury of Aggravated Robbery. After his jury trial, Drummond made a phone call to his father where he threated the jurors and the victim in this case. He made statements saying, "They are going to regret it" and "I'll be out one day." Drummonds behavior while in prison should also be taken into consideration. He has 25 disciplinary actions against him that include refusing orders, drug possession, defiance, and being in possession of a deadly weapon. This type of behavior clearly demonstrates that Drummond has no desire for rehabilitation and is not capable of living among society.

Due to the seriousness of the crimes he committed, his violent behavior towards the victims in these cases and to protect society from his criminal behavior, we feel that he should remain in prison and serve his sentence in full.
