whose name is otherwise unknown to the affiant, committed the offense of Sexual Battery TCA 39-13-505
in the above county on or about October 10th 2025

Further, affiant makes oath that the essential facts constituting said offense, the sources of affiant's information, and the reasons why his/her information is believable concerning said facts are as follows:

Occurring in the City of Dyersburg, in Dyer County Tennessee the above named defendant committed the offense of Sexual Battery at 1335 Flowering Dogwood Lane (Beasley Chiropractic). The Victim, had an appointment with the defendant at this location for a massage. During the Massage the defendant touched and groped the victim's breasts in a way that was not part of the massage and causing the victim both fear and embarrassment. A medical professional made contact with the defendant to ask about the reported assault, and he admitted that he had let things go to far, and that he did not know why he did what he did. This conversation was recorded by the Medical Professional and has been turned over to police. The defendant is being charged with Sexual Battery.
