AFFIDAVIT OF COMPLAINT

I, the affiant named below, after being sworn, state under oath that on or about the year of 2023

in Madison County, Tennessee,

committed the offense(s) of violation(s) of T.C.A. § 39-15-510 Abuse of a Vulnerable Adult.

I further state under oath that the essential facts constituting the offense(s), the sources of my information and the reasons why this information is believable and reliable are as follows:

Your Affiant, Special Agent Joshua Fields with the Tennessee Bureau of Investigation, states that on March 9th, 2026, he received a tip, as well as 3 videos, from personnel with the Department of Disability and Aging (DDA). One of these videos shows Cumekia Conner, a caregiver with Encare LLC at the time, physically abusing [redacted] who is a non-verbal autistic male. This video depicts Cumekia Conner open hand slap [redacted] in the face six (6) times, pause briefly, and then swing five (5) additional times towards his face. The end of the video also shows Cumekia swing what appears to be a binder notebook towards [redacted]. Another video shows Cumekia holding a white board in a raised striking position, and threatening [redacted] stating, "Go sit down before you get some more licks." The exact date of the incident is unknown, but occurred sometime in 2023 at [redacted] Jackson, TN 38305.
